

Privacy policy

This Privacy Policy ("Privacy Policy") applies to <https://blackseacuisine.world> website (hereinafter, «us» or «we»). We have adopted this privacy policy to explain what information may be collected on our website, how we use this information, and under what circumstances we may disclose the information to third parties. What User Data We Collect

Our website typically collects two kinds of information about you: (a) information that you provide which personally identifies you; and (b) information that does not personally identify you which we automatically collect when you visit our website or that you provide us. Our Cookie Policy
